FOR THE PURPOSE OF THIS CONTRACT, THE TERM "PHOTOGRAPHS" SHALL PERTAIN TO "STILL IMAGES AS WELL AS "VIDEO CLIPS"  
FOR THE PURPOSE OF THIS CONTRACT, THE TERM "PHOTOGRAPHER" SHALL PERTAIN TO "EITHER CONVENTIONAL PHOTOGRAPHER AND/OR VIDEOGRAPHER"

1. I, \_\_\_\_\_ explicitly grant to the photographer and to his or her assignees, licensees the absolute right and permission to use, publish or sell photograph(s) referred to below, in which I am included, in any medium, throughout the world, without any restriction whatsoever as to the nature of the use or publication or as to the copy of any printed matter accompanying the photograph(s). I understand that the images may be altered and I waive the right to approve of any finished product.
2. The Client shall reimburse Photographer for any additional costs the Photographer may incur for travel, meals, parking, and other reasonable costs necessary to the performance of these services.
3. Any money paid down is non refundable if the client cancels or changes date of event.
4. Final photos will be displayed for the first time either during an in-person print consultation if client is local, or an online gallery if non-local. In order to spend Print Credit (if available), client must attend consultation if any way possible. Final "medium resolution" product will be delivered by digital download. Disc or flash drive delivery can be purchased separately on the gallery.
5. The Client shall assist and cooperate with the Photographer in obtaining the desired photographs, including but not limited to specifying persons and/or scenes to be photographed; taking time to pose for photographs at the Photographer's direction; providing a person to guide the Photographer to desired persons and/or scenes; pre-shoot consultations, etc. The Photographer shall not be responsible for photographs not taken as a result of the Client's failure to provide reasonable assistance, cooperation, and a reasonably lit atmosphere.
6. The Photographer retains copyright in the photographs, and hereby grants the Client unlimited but non-exclusive rights to use or reproduce the photographs for which the Client pays.
7. If damage occurs to any company owned equipment at the fault of the client or client's guests, client is responsible for repair or replacement.
8. If any damage occurs to any company owned equipment due to client choosing to go forward in spite of rain or inclement weather instead of a backup indoor location, client is responsible for repair or replacement.
9. By signing below, client understands that even though we aim at a 45 to 60 day turn around, photo and or video can take up to 90 days to be edited and delivered.
10. If you wish to receive digital images from our photo booth, client must either provide a suitable flash drive or mem card at the event or purchase one from us during the booking process. If neither occur, you waive your rights to ANY digital copies from the Photo Booth.
11. I understand that the only drone footage guaranteed (if purchased) is of the venue and scenery and that operation of the drone will be dependant on weather conditions, public safety, and safety of the drone. (Discretion of the pilot) Any other requests will have to be made in writing and agreed upon by all parties.
12. Final image selection for delivery is at the discretion of JWE
13. Photo / Video packages must be paid in full by the end of the event. In the unlikely circumstance that client does not hold up their end of contractual obligations, JWE will be due all moneys spent on court, collections, and attorney fees.
14. All friends and family members need to understand that JWE has been hired to do your photo and or video, therefore will not hinder our ability to do so. Example: If uncle Bill stands beside us during all your formal group shots with his camera or cell phone, no one in the shot will know which camera to smile at. Example: How amazing is that shot of you and your new spouse's first kiss going to be with Aunt Brenda leaning over into the aisle with her ipad? Google "unplugged wedding" and you may see the benefits of restricting the use of devices all together.
